THE TDA - SAP

The Drin Transboundary Diagnostic Analysis (TDA) prepared identified four transboundary issues, likely to be exacerbated by **climate variability and change:**

- Deterioration of Water Quality
- Natural and Regulated Variability of Hydrological Regime
- Biodiversity Degradation
- Variability of Sediment Transport Regime

A Strategic Action Programme (SAP) was prepared through a drafting and consultation process that lasted one year and involved ~200 stakeholders and 30 experts. The Drin Basin SAP draws on the Drin MoU. The SAP includes 'Goals' to be achieved through the implementation of specific Objectives. For each Objective, a series of Management Actions are detailed which includes: Timescale; Priority; Location; Responsible organisation; Financing; Budget; Indicators; Impact of action on water resources/ecosystem.
